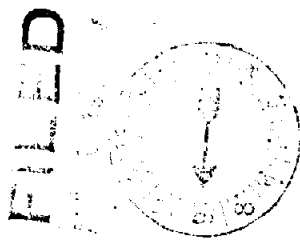

To All Whom These Presents May Concern:

We, Charlie Hill and Annie Mae J. Hill

SEND GREETING:

WHEREAS, we the said Charlie Hill and Annie Mae J. Hill
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
Three Thousand Five Hundred and no/100 - - - - (\$ 3,500.00) Dollars,
with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

Fifty-six and no/100 - - - - (\$ 56.00) dollars
due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest
and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments
to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any,
incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder
shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of
said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at
the option of the holder become immediately due and payable, and said note further providing for a reasonable
attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible
as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected
by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said Charlie Hill and
Annie Mae J. Hill, in consideration of the said debt and sums of money
aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION,
Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND
LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter con-
structed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, on the northern side of a settlement road and having, according to a survey
of property of Grace E. Greer, prepared by Terry T. Dill dated July 18, 1957, the
following metes and bounds, to-wit:

BEGINNING at an iron pin in the center line of said
settlement road at corner of property now or formerly belonging to Lillie McC. Loftis
and running thence along the center line of said road S. 81 W. 100 feet to an iron
pin; thence continuing with said road N. 87-26 W. 100 feet to an iron pin; thence still
with said road N. 76-21 W. 110 feet to an iron pin; thence N. 16-45 W. 620 feet to an
iron pin; thence N. 64-00 E. 215 feet to an iron pin in line of said Loftis property;
thence along said line S. 22-30 E. 760 feet to an iron pin, the point of beginning, and
containing 4.0 acres, more or less.

The above is a portion of the property devised to Grace E. Greer by J. W. Greer and
is a portion of the ten acres, more or less, conveyed to J. W. Greer by James H. Priestly
by deed dated March 22, 1932 and recorded in the R. M. C. Office for Greenville County
in Deed Book 161, page 148.

This is the same property conveyed to us by Grace E. Greer by Deed dated July 27,
1957 and recorded in R. M. C. Office in Book 581 at page 97.

ALSO: All that certain lot of land in County of Greenville, Chick Springs Township,
near the Town of Taylors, South of the Southern Railroad, and being the same lot of land
conveyed to me by Macio Greer, having the following courses and distances, to wit:

BEGINNING on an iron pin in the road, or Street that leads to the Golf Course and
Southern Bleachery Athletic Field, joint corner of the Jessie Bennett lot, and runs
thence with the dividing line of the Bennett lot and of this lot S. 38 1/2 W 3.38 chains
to iron pin on the Preston Bennett line; thence with the Preston Bennett line S 55 1/2 E
eighty(80) links to iron pin, joint corner of the Raymond Greer lot; thence with the
dividing line of the Greer lot and of this lot N 38 1/2 E 3.38 chains to iron pin in the
said road; thence with the said road S 55 1/2 W eighty (80) links to the beginning corner.
Containing twenty-seven one-hundredths (0.27) of One Acre, more or less.
