WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Ten Thousand and No/100 ----- DOLLARS (\$ 10,000.00), with interest thereon from date at the rate of five & three-fourths per centum per annum, said principal and interest to be repaid as therein stated, and (5 3 /4)

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of U. S. Highway 29 in Chick Springs Township, being shown and designated as Lots 3 and 4 on plat of the subdivision of B. F. Flynn Estate recorded in Plat Book R, Page 81, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the southern side of U. S. Highway 29 at northeastern corner of Lot 2 and running thence S. 22-45 E. 200 feet along line of Lot 2 to stake; thence N. 67-15 E. 100 feet to stake at corner of Lot 5; thence with the line of Lot 5 N. 22-45 W. 200 feet to stake on right-of-way of Highway 29; thence S. 67-15 W. 100 feet to the point of beginning.
