James M. Bryan and Hilda K. Bryan of Mauldin, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina: in the Town of Mauldin, S. C. on the southern side of Crestwood Drive and being known and designated as Lot No. 53A and the western one-half (1/2) of Lot No. 52 of Peachtree Terrace as shown on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "EE", at Page 189, said property fronting 141.3 feet on the southern side of Crestwood Drive and running back to a depth of 159.1 feet on the western side and to a depth of 169.1 feet on the eastern side, and being 158.2 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
