SEND GREETINGS:

GREENVILLE, in the full and just sum of Seven Thousand One Hundred & no/100 (\$7,100.00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of
