SEND GREETING:

Whereas, the said LONGVIEW INCORPORATED,  
a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to Citizens Bank of Fountain Inn, South Carolina in the full and just sum of Two Thousand Five Hundred (2,500.00) Dollars

, to be paid in equal monthly installments of Forty (40.00) Dollars each until paid in full. The first such installment becoming due and payable on the 10th day of May, 1959 and a like installment on the 10th day of each month thereafter until paid in full. Such installments are to be first applied toward the payment of interest and the balance toward the reduction of the principal. The obligor hereof reserves the privilege of paying all, or any part of the balance due, with interest thereon from \_\_\_\_\_ date \_\_\_\_\_ hereon, on installment paying date at the rate of 6 per centum per annum, to be computed and paid monthly as stated above

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

ALL that piece, parcel or lot of land, with improvements thereon, located in Greenville Township, Greenville County, State of South Carolina and in the City of Greenville on the North side of Mulberry Street known and designated as number 209 Mulberry Street and having a frontage on Mulberry Street of 75 feet, more or less, and a depth of 85 feet, more or less, and consisting of approximately 6,375 square feet.
