interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid,
the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who
may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the
hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof
necessary for the protection of his interests to place and the holder should place the said note or this mortgage

Webb property of the 31st day of May, 1958, being bounded by Lot No.
4 of said Survey and Plat, lands of Sara M. Sargent, Troy Allen and an
unnamed Street. Being the identical lot of land conveyed to us by deed
of George W. Webb to be recorded.
