LLOYD D. CHAMBERS of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land situate, lying and being
in Greenville County, South Carolina, known and designated as Lot
No. 2 as shown on a plat of the subdivision of Property of Talmer
Cordell and James H. Campbell, recorded in the R. M. C. Office
for Greenville County in Plat Book Z, Page 175.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.
