sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its

All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being on the northerly side of Cateechee Avenue, in the
City of Greenville, S. C., and being shown as Lot No. 76 on the plat of Cherokee
Park as recorded in the RMC Office for Greenville County, S. C. in Plat Book C,
page 96, said lot fronting 60 feet on the northerly side of Cateechee Avenue and
