and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville ,
State of South Carolina:

All that piece, parcel or lot of land in Greenville County, state
of South Carolina, known and designated as Lot No. 63, as shown on
plat of Augusta Acres, recorded in plat book S, page 201, of the
RMC Office for Greenville County, said lot having a frontage of 100
ft. on the eastern side of Meadors Avenue, a depth of 200 feet on
the northern side, a depth of 200.4 feet on the southern side, and
a rear width of 82.3 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
