"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the south side of Virginia Avenue in the City of Green, and being Lot No. 53, plat of Development No. 2, Victor-Monaghan Co., Division of J.P. Stevens & Co., Inc., Green Plant, by Dalton & Neves, Engineers, April, 1947, recorded in Plat Book P, page 119, R.M.C. Office for Greenville County, and having the following courses and distances, to wit:
