WHEREAS, the Mortgagor is well and truly indebted unto AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twelve Thousand Four Hundred Fifty Dollars (\$ 12,450.00), with interest from date at the rate of five & 1/4 per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-eight and 85/100 - - Dollars (\$ 68.85), commencing on the first day of June, 19 59, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May, 19 89.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the county of Greenville, state of South Carolina, known and designated as Lot No. 9 on plat No. 2 of the B. P. Crenshaw property recorded in plat book LL page 142 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by C. C. Jones, April 1959, the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the northeast side of Jaben Drive, the front joint corner of Lots Nos. 9 and 10; thence with the joint line of said lots N. 54-55 E. 118.1 feet to an iron pin; thence S. 59-41 E. 72.6 feet to an iron pin; thence S. 16-30 W. 36.2 feet to an iron pin rear corner of Lot No. 8; thence with the line of said lot S. 61-39 W. 130 feet to an iron pin on the northeast side of Jaben Drive; thence with the northeast side of said Street N. 28-21 W. 75 feet to the beginning corner.
