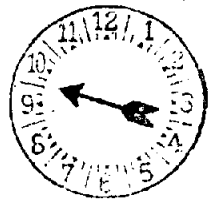

SEND GREETING:

Whereas, we, the said Earl Pearson and Arie Pearson
