Clyde G. Hardy and Norma S. Hardy of  
Simpsonville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto C. Douglas Wilson & Co.

, a corporation

securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three  
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing  
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,  
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its  
successors and assigns, the following-described real estate situated in the County of Greenville ,  
State of South Carolina: at Simpsonville, S. C. on the northwestern side of Morgan  
Circle and being known and designated as Lot No. 36 of Roland Heights as shown  
on plat thereof recorded in the R. M. C. Office for Greenville County, S. C. in  
Plat Book "S", at Page 34, said lot fronting 80 feet on the northwestern side of  
Morgan Circle and running back in parallel lines to a depth of 175 feet and being  
80 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-  
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be  
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter  
attached to or used in connection with the real estate herein described.

assigns forever.
