Greenville, S. C. , hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Aiken Loan & Security Company

All that lot of land in the county of Greenville, state of South
Carolina, known and designated as Lot No. 207, Section A, on plat of
Woodfields, Inc. recorded in plat book W page 75 of the RMC Office
for Greenville County, S. C., said lot having a frontage of 70 feet
on the southeast side of Foxhall Road, a parallel depth of 170 feet
and a rear width of 70 feet.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
