All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the South side of Pliney Circle, in the Town of Simpsonville, being all of lot No. 37 on a plat of the subdivision known as League Estates made by W. J. Riddle, Surveyor, dated October, 1941, recorded in Plat Book "K", at pages 111 and 112, in the R. M. C. Office for Greenville County, and having the following courses and distances:  
BEGINNING on an iron pin at the northeast corner of lot No. 38 and runs thence along the south side of South Pliney Circle N. 67.23 E. 105 feet to corner of lot No. 36; thence with line of lot No. 36 S. 19.45 E 173 feet to an iron pin; thence S. 64.50 W. 105 feet to corner of lot No. 38; thence with the line of lot No. 38; thence N. 19.45 W. 177.4 feet to the beginning corner, this being the same property as conveyed to mortgagor in deed book 394, Page 329.
