(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100-----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the northeast side of Skyland Drive (formerly Bates Avenue) in the City of Greenville, being shown as lot # 30 on a plat of Skyland Park, recorded in Plat Book L at Page 41 and described as follows:

BEGINNING at a stake on the northeast side of Skyland Drive, 339 feet southeast from Ackley Street, at the corner of lot # 31, and running thence with the northeast side of said drive, S. 43-27 E. 50 feet to a stake, corner of lot # 29; thence with the line of said lot N. 46-33 E. 138.8 feet to a stake; thence N. 47-00 W. 50.1 feet to a stake at the corner of lot # 31; thence with the line of said lot, S. 46-33 W. 135.8 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Book of Deeds 234 at Page 339.
