TO ALL WHOM THESE PRESENTS MAY CONCERN:

A. J. Mauldin and Martha C. Vess, as (hereinafter referred to as Mortgagor) SEND(S) GREETING:
Trustee for J. S. Mauldin,
WHEREAS, the Mortgagor is well and truly indebted unto Walter J. Williams

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

THREE THOUSAND AND NO/100----- DOLLARS (\$ 3,000.00),

with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid:

\$750.00 on principal on January 15, 1960, and \$750.00 on principal semi-annually thereafter, with interest at 6% from date, with the right to anticipate payment at any time after January 15, 1960, interest to be computed and paid semi-annually.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Eastern side of Orders Street (formerly Second Avenue) in Greenville County, State of South Carolina, being shown and designated as Lots 8 and 9 on a plat of the property of Poe Manufacturing Co., recorded in Plat Book Y at page 30, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Orders Street, (formerly Second Avenue,) which pin is 200 feet in a Northerly direction from Fourth Street, and running thence N. 89-45 E. 150 feet to a pin on an alley; thence with the Western side of said alley, N. 9-17 E. 100 feet to a pin; thence S. 89-45 W. 150 feet to pin on Orders Street; thence with the Eastern side of Orders Street, S. 9-17 W. 100 feet to the point of beginning.

Being the same property conveyed to mortgagors by deed of Walter J. Williams of even date, to be recorded herewith.

This mortgage is given to secure the unpaid purchase price.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
