ALL that lot of land with the buildings and improvements thereon situate on the West side of East Belvedere Road, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 28 on plat of South Forest Estates, made by Pickell & Pickell, Engineers, August 29, 1955, recorded in the RMC Office for Greenville County, S. C., in Plat Book GG, page 181; said lot fronting 90 feet along the West side of East Belvedere Road, running back to a depth of 125 feet on the South side, to a depth of 125 feet on the North side, and being 90 feet across the rear.
