All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Saluda Township, containing 5 acres more or less according to plat of property of William B. Darnell of record in the R.M.C. Office for Greenville County in plat book 00 at page 56 and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of Buncombe Road at the corner of Hoke Hawkins; thence along his line N 89-58 W, 1240 feet to an iron pin near a branch; thence on a traverse line, the branch being the line the following courses and distances, to-wit: S 2-30 E, 213 feet, to an iron pin; thence N 89-56 E, 853 feet to an iron pin; thence N 0-04 W, 113 feet to an iron pin; thence N 89-56 E, 366 feet to an iron pin on the western side of Buncombe Road; thence with said road N 8-27 W, 100 feet to the point of beginning and being the same property conveyed to us in deed book 549 at page 93.
