 "All ~~that~~ certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying on the Southeast side of Mt. Eustis Street (also referred to as Beattie St.) in the City of Greenville, being shown as Lots 21 and 22 on a plat of F. F. Beattie Subdivision, recorded in Plat Book C at 236 and according to said plat being more particularly described as follows:

BEGINNING at an iron pin on the Southeast side of Mt. Eustis Street, joint front corner of Lots 22 and 23, which pin is 80 feet Southwest of the intersection of said street with Summitt Street, and running thence with the Southeast side of said Street, S. 52 W. 80 feet to an iron pin, joint front corner of Lots 20 and 21; thence with the line of said lots, S. 42-20 E. 100 feet to an iron pin; thence with the rear line of Lots 21 and 22, N. 52 E. 80 feet to an iron pin, joint rear corner of Lots 22 and 23; thence with the line of said lots, N. 42-20 W. 100 feet to the Beginning corner.
