WHEREAS, the Mortgagor is well and truly indebted unto

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 4 as shown on a plat prepared by T.J. McCoy, Surveyor, dated August 27, 1955, entitled "Cedar Lane Gardens", recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG at page 139, and having according to a more recent plat prepared by Piedmont Engineering Service, dated June 23, 1959, entitled "Property of Dee D. Bishop, Jr. and Mildred B. Bishop", the following metes and bounds:

BEGINNING at a concrete monument on the Northwestern side of Orchid Drive at the joint front corner of Lots Nos. 3 and 4, and running thence with the line of Lot No. 4 N. 44-35 W. 150.4 feet to an iron pin on the subdivision property line; thence with the subdivision property line N. 49-11 E. 80 feet to an iron pin at the joint rear corner of Lots Nos. 4 and 5; thence with the line of Lot No. 5 S. 40-49 E. 150 feet to an iron pin on the Northwestern side of Orchid Drive; thence with the Northwestern side of Orchid Drive S. 49-11 W. 70 feet to the point of beginning.
