situate on the South side of Arthur Avenue, in the City of Greenville,
in Greenville County, State of South Carolina, being shown as Lot 17,
Block O, on plat of O.P. Mills property, recorded in the RMC Office
for Greenville County, S.C. in Plat Book F, page 299, said lot fronting
60 feet along the South side of Arthur Avenue, and running back to a
depth of 192.9 feet on the East Side, to a depth of 180 feet on the
West side and being 58 feet across the rear.
