WHEREAS, the Mortgagor is well and truly indebted unto

ALL those lots of land with the buildings and improvements thereon, situate on the South side of McDowell Street, near the City of Greenville, in Greenville County, South Carolina, being shown as Lots 17, 13 and 19, Block C, on plat of Woodville Heights, made by W. J. Riddle, Surveyor, December 1940, recorded in the R.M.C. Office for Greenville County, S. C. in Plat Book L, at pages 14 and 15, said lots having a frontage along the South side of McDowell Street of 189.2 feet, and running back to a depth of 209.9 feet on the West side, to a depth of 231 feet on the East side, and being 160 feet across the rear.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
