First Mortgage on Real Estate

MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

R. C. and Lucille Brown (hereinafter referred to as Mortgagor) SEND(S) GREETING:
Parker

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Five Thousand and No/100

DOLLARS (\$ 5,000.00), with interest thereon from date at the rate of Five & Three-Fourths per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

on the southern corner of Cammer Avenue, and Low Hill Street, in the City of Greenville, being shown as lot # 46 on plat of Augusta Road Hills, recorded in Plat Book L at Page 59, and described as follows:

BEGINNING at a stake on the southeast side of Cammer Avenue, at corner of lot # 45, and running thence with the southeast side of said Avenue, N 42-10 E. 51.4 feet to iron pin at the corner of Low Hill Street; thence with the curve of the intersection, the chord of which is S. 89-52 E. 44.3 feet to iron pin on Low Hill Street; thence with the southwest side of said street, S. 41-55 E. 132.9 feet to iron pin at the corner of lot # 47; thence with the line of said lot, S. 42-10 W. 67.1 feet to iron pin at the corner of lot # 45; thence with the line of said lot, N. 47-50 W. 165 feet to the beginning corner.

Being the same premises conveyed to the mortgagors by deed recorded in Book of Deeds 241 at Page 346.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
