RELEASE FROM MORTGAGE

BEGINNING at an iron pin on the northern side of a county road, joint front corner of Lots 1-A and 1-B, and running thence along the joint line of said lots, N. 6-30 W. 175 feet to an iron pin on the line of Grace Greer property; thence along the line of that property, N. 65-00 E. 55 feet to an iron pin at the rear corner of Lot 1-C; thence along the line of that lot, S. 8-42 E. 184.8 feet to an iron pin on the northern side of said county road; thence along the northern side of said county road, S. 76-00 W. 60 feet to the beginning corner.
