MORTGAGE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

George M. Cummings

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Frank E. Estes, Executor of the Estate of William H. Estes, deceased

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of

FIFTEEN HUNDRED AND NO/100-----

DOLLARS (\$ 1500.00),

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid:

\$100.00 on October 15, 1959, and \$100.00 each six months thereafter until paid in full, said payments to be first applied to interest, balance to principal, with interest from date at the rate of six (6%) per cent, per annum, to be computed and paid semi-annually, until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the north-western side of Anderson Road, Greenville county, being shown as Lot 150 and one-half of Lot 149 on a plat of Pride Patton Land Company, recorded in Plat Book G at page 33, and being more particularly described as follows:

BEGINNING at an iron pin on the Northwestern side of Anderson Road, 50 feet from the Northeast corner of the intersection of Wilburn Avenue and Anderson Road and running thence N. 46-34 W. 173.1 feet to an iron pin in line of Lot 20; thence with the line of Lot 20, N. 44-03 E. 75 feet to an iron pin in the center of the rear line of Lot 149; thence S. 46-34 E. 173.9 feet, more or less, to pin on Anderson Road; thence with the Northwestern side of Anderson Road, S. 44-03 E. 75 feet to the point of beginning.

Being the same property conveyed to Mortgagor by deed of Frank Estes, Executor under the will of William H. Estes, of even date, to be recorded herewith.

It is understood and agreed that the lien of this mortgage is junior to the lien of a mortgage given by mortgagor to Fidelity Federal Savings & Loan Association in the sum of \$3,500.00, of even date herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
