

Coast #1 Well in Section 34, Township 15 South, Range 19 East, Lafourche Parish, Louisiana; Thence, South 34° 29' West a distance of 246.3 feet to the Northeast corner of the proposed meter station site, the place of beginning; Thence, South 22° 55' East a distance of 26 feet to the Southeast corner of said site; Thence, South 67° 5' West a distance of 12 feet to the Southwest corner of said site; Thence, North 22° 55' West a distance of 26 feet to the Northwest Corner of said site; Thence, North 67° 05' East a distance of 12 feet to the Place of Beginning, Containing .0072 acres of land, more or less as shown on the Exhibit "A" which is attached thereto and made a part thereof, and as further shown as the area delineated in red on Exhibit "B" which is attached thereto and made a part thereof.

Compressor Station No. 35
