FOURTH

STORAGE PROPERTIES AND GAS RESERVES

All of the right, title and interest of the Company in and to (1) the gas storage rights and related rights, titles and interests, (2) the gas wells, casing, well equipment and related property and appurtenant facilities, (3) all of the natural gas and (4) all other properties of whatever character not described or identified in Granting Clauses First, Second and Third hereinabove conveyed to the Company by the instruments herein below described:

(a) Deed of Conveyance, Assignment and Bill of Sale dated December 19, 1958, from New York State Natural Gas Corporation conveying to the Company an undivided one-fourth interest in certain storage properties located in Clinton County, Pennsylvania (recorded in Deed Book 189, page 167 in the Recorder's Office of Clinton County, Pennsylvania).

(b) Deed of Conveyance, Assignment and Bill of Sale dated December 19, 1958, from New York State Natural Gas Corporation conveying to the Company an undivided one-fourth interest in certain storage properties located in Potter County, Pennsylvania (recorded in the Office for Recording of Deeds, in and for the County of Potter in Misc. Book D-2, Page 527).

(c) Assignment dated December 19, 1958, from New York State Natural Gas Corporation conveying to the Company an undivided one-fourth interest in certain storage properties in Cameron County, Pennsylvania (recorded in the Recorder's

Office of Cameron County, Pennsylvania in Misc. Book, Vol. U, page 108).

(d) Deed of Conveyance and Assignment dated December 19, 1958, from New York State Natural Gas Corporation conveying to the Company certain reserves of natural gas in Potter and Clinton Counties, Pennsylvania (recorded in the Office for Recording of Deeds in and for Potter County, Pennsylvania in Misc. Book D-2, page 537 and in the Recorder's Office of Clinton County, Pennsylvania in Deed Book 189, page 206).

(e) Deed of Conveyance, Assignment and Bill of Sale dated March 31, 1959, from New York State Natural Gas Corporation conveying to the Company an undivided one-fourth interest in certain storage properties located in Clinton County, Pennsylvania (recorded in Misc. Docket #44 Page 329 in the Recorder's Office of Clinton County, Pennsylvania).

MINERAL INTERESTS

All the right, title and interest of the Company under, in and to the following assignment of limited overriding royalty interest and production payment:

(a) Assignment dated March 20, 1959 from DDG Gas and Oil Corporation conveying to Transcontinental Gas Pipe Line Corporation certain oil, gas and mineral interest in Goliad and McMullen Counties, Texas, as a limited overriding royalty interest and production payment to secure and provide for the payment of amounts therein set out (recorded in Volume 184, page 382, of the Deed Records of Goliad County, Texas and in Volume 71, page 562, of the Deed Records of McMullen County, Texas).
