To All Whom These Presents May Concern:

We, V. W. Rollins and Pearl Beatrice T. Rollins SEND GREETING:

WHEREAS, we the said V. W. Rollins and Pearl Beatrice T. Rollins
in and by our certain promissory note in writing of even date with these Presents, are well
and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of
Two Thousand One Hundred and no/100 - - - - (\$ 2,100.00) Dollars,
with interest from the date hereof at the rate of seven per cent (7 %) per annum, unpaid interest to
bear interest at the same rate, to be repaid in installments of

Thirty-three and 60/100 - - - - (\$ 33.60) dollars
due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest
and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments

by an attorney or by legal proceedings of any kind.

KNOW ALL MEN BY THESE PRESENTS, That we the said V. W. Rollins and
Pearl Beatrice T. Rollins, in consideration of the said debt and sums of money
aforesaid, and for the better securing the payment thereof to the said CITIZENS BUILDING AND LOAN ASSOCIATION,
Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00)
Dollars to us the said mortgagors in hand well and truly paid by the said mortgagee, at and
before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained,
sold and released, and by these Presents do grant, bargain, sell and release unto the said CITIZENS BUILDING AND
LOAN ASSOCIATION, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter con-
structed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs
Township, near the northern edge of the corporate limits of the town of Greer, lying
on the south side of the U. S. Super Highway No. 29 being shown and designated as lot
No. 4 on plat of property of J. C. Moon Estate prepared by H. S. Brockman, Surveyor,
June 12th, 1947, and being the same lot of land conveyed to us by deed from Annie M.
Turner et al, and having the following courses and distances, to-wit:-

BEGINNING on a stake on the southern edge of the Right of Way of the said Super Highway,
joint corner of lots 3 and 4, and runs thence with the dividing line of lots 3 and 4
S. 4-50 W. 55.5 feet to a stake on the north edge of an unnamed street; thence with the
north edge of the said street S. 82-50 E. 93.3 feet to a stake in the intersecting
corner of the said unnamed street and of Earle Street; thence with the west edge of
Earle Street N. 2-13 W. 59.3 feet to a stake in the southern edge of the Right of Way of
the said Super Highway; thence with the southern edge of the said highway N. 85-00 W.
86 feet to the beginning corner.

ALSO, all that other certain piece, parcel or lot of land and the improvements thereon,
situate, lying and being in the State and County aforesaid, Chick Springs Township,
being located in the southwest intersection of Earle Street and of an unnamed street,
and being shown and designated as lot No. 7 on the plat above referred to, and being
one of the same lots conveyed to us by deed from Annie M. Turner, and others, and
having the following courses and distances, to-wit:-

BEGINNING on a stake on the south
side of the said unnamed street, joint corner of lots 7 and 8, and runs thence with
the dividing line of lots 7 and 8 S. 7-11 W. 138.1 feet to a stake on the line of lot
No. 9; thence with the dividing line of lots 7 and 9 S. 82-29 E. 100 feet to a stake
on the west side of Earle Street; thence with the west side of Earle Street N. 9-25 W.
140 feet to a point in the intersection of Earle Street and the said unnamed street;
N. 82-29 W. 60 feet to the beginning corner.
