To All Whom These Presents May Concern:

We, E. K. Link and Mable M. Link, of Greenville County, S. C. SEND GREETING:

Whereas we, the said E. K. Link and Mable M. Link,  
in and by our certain promissory note in writing, of even date with these  
Presents, are well and truly indebted to John A. Park,  
in the full and just sum of FIVE HUNDRED and no/100 (\$500.00) DOLLARS,

to be paid as follows: FIFTY (\$50.00) DOLLARS on October  
1, 1959, and a like sum on the 1st day of each and every succeeding  
Calendar month thereafter, each of said payments to be applied first to  
the interest and then to the principal balance owing, until paid in  
full,

, with interest thereon from date  
quarterly  
at the rate of Six per centum per annum, to be computed and paid monthly, as above,

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and  
unpaid, the whole amount evidenced by said note to become immediately due, at the option of the  
holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its  
maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity  
it should be deemed by the holder thereof necessary for the protection of his interests to place and  
the holder should place the said note or this mortgage in the hands of an attorney for any legal  
proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses  
including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness,  
and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, that we, the said E. K. Link and Mable M. Link,  
, in consideration of the said debt and  
sum of money aforesaid, and for the better securing the payment thereof to the said John A. Park,  
according to the terms of the said note, and also in

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted,  
bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said  
John A. Park, his heirs and assigns,

All that certain piece, parcel lot or tract of land, situate and  
being in Paris Mountain Township, Greenville County, State of South  
Carolina, on the northern side of Parker Road, and having the following  
metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of said Parker Road,  
corner now, or formerly, of Mrs. C. H. Walker, and running thence with  
the Walker line, N. 56 E. 269.8 feet to iron pin; thence N. 36-10 W. 47  
feet to iron pin; thence S. 56 W. 10 feet, more or less, to iron pin;  
thence N. 23 W. 20 feet to iron pin; thence S. 56-40 W. 228.5 feet to  
iron pin on Parker Road; thence with Parker Road, S. 23 E. 70 feet to  
the point of beginning; and being the same property conveyed to the  
Mortgagors herein by E. B. Wynn by three separate deeds: Deed of July 7,  
1956, recorded in the R.M.C. office in Vol. 565 at page 119; Deed dated  
March 13, 1957, recorded in said R.M.C. office in Vol. 576 at page 46;
