All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near the City of Greenville, on the northeast side of S. C. Highway 291, being known and designated as Lot No. 1 according to plat of property of Pearl D. Matthews made by Dalton & Neves, Engineers, September, 1949, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book TT at page 15 and having, according to said plat, the following metes and bounds, to-wit:
