TO ALL WHOM THESE PRESENTS MAY CONCERN: We, Ronald W. Norman and Winnifred J.

Norman (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Aubrey C. Shives and Romayne A. Barnes

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of -----

Nine Hundred Twenty-Five and No/100 ----- DOLLARS (\$ 925.00),

with interest thereon from date at the rate of five (5) per centum per annum, said principal and interest to be repaid:

Payable six (6) months from date, with interest from date at the rate of five (5) per cent., per annum, to be computed and paid semi-annually, until paid in full.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the southern side of Ashley Avenue, being known and designated as Lot No. 18 and the eastern one-half of Lot No. 19, on plat of the property of B. E. Geer, recorded in Plat Book H at Page 177, in the R. M. C. Office for Greenville County, and being more particularly described as follows:

"Beginning at an iron pin on the southern side of Ashley Avenue, joint front corner of Lots 17 and 18, and running thence with line of Lot 17, S. 24-30 W. 200 feet to an iron pin; thence N. 65-30 W. 82.5 feet to an iron pin in the center of Lot 19; thence with line through the center of Lot 19, N. 24-30 E. 200 feet to iron pin on Ashley Avenue; thence with said Ashley Avenue, S. 65-30 E. 82.5 feet to the point of beginning; being the same premises conveyed to the mortgagors by Margaret W. Jones by deed to be recorded herewith."

It is understood that this mortgage is junior in lien to one of even date executed by the mortgagors to Fidelity Federal Savings and Loan Association in the sum of \$14,250.00, to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
