All that piece, parcel or lot of land situate, lying and being in Greenville County, State of South Carolina, on the southwestern corner of the intersection of North Wingate Road and June Lane and being known and designated as Lot No. 23 of Pecan Terrace, Section 2, as shown on plat thereof recorded in the RMC Office for Greenville County in Plat Book "EE" at page 108 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the western side of June Lane at the joint front corner of Lots Nos. 23 and 24 and running thence along the joint line of said Lots S. 80-12 W. 120.4 feet to an iron pin; thence N. 12-32 W. 111 feet to an iron pin; thence along the southern side of North Wingate Road N. 70-45 E. 78 feet to an iron pin; thence with the curve of the intersection of said Road and June Lane, the chord of which is S. 66-18 E. 36.6 feet to an iron pin; thence along the western side of said Lane S. 23-30 E. 55.8 feet to an iron pin; S. 16-20 E. 50 feet to the point of beginning.
