We, W. G. Corn and Naida O. Corn, Wife

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that piece, parcel or lot of land in Glassy Mountain Township, Greenville County, State of South Carolina, lying and being on the Oak Grove Church Road Beginning: At a double Post Oak stump, corner of the Plumley Estate land on said Oak Grove Church Road, and runs with said road north 62 degrees 15 minutes east 208.7 feet to an iron pin; thence at right angles and with my line north 15 degrees west 208.7 feet to an iron pin; thence again at right angles south 62 degrees 15 minutes west 208.7 feet to an iron pin on the Plumley line; thence with the Plumley line south 15 degrees east 208.7 feet to the beginning corner, containing one (1) acre more or less.
