WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

For ty-five Hundred ---DOLLARS (\$ 4500.00 ), with interest thereon from date at the rate of per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chicks Springs, Township, lying on the west side of Line Street, being shown and designated as Lot No. 5 on a plat of property made for J. Walter McCarter by H.S. Brockman, Surveyor, February 24, 1951, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the western margin of Line Street corner with Greer Armory lot, and runs thence N. 50 W. 203.2 feet to an iron pin on line of Greer Armory lot; thence N. 12-45 E. 28.9 feet to an iron pin, joint rear corner of Lots Nos. 4 and 5; thence with the common line of Lots Nos. 4 and 5, S. 74-19 E. 160.5 feet to an iron pin on the western margin of Line Street; thence along the line of said street, S. 2-25 W. 114.4 feet to the beginning.

The above described lot is the greater portion of Lot No. 5 and is also a small part of Lot No. 4 of that property shown on a plat made for Mrs. Elizabeth T. Westmoreland by W.B. Neves, Engineers, dated June 26, 1920, the Brockman plat referred to above showing a re-subdivision of Lots Nos. 3, 4, and 5 on the Westmoreland plat.
