

BEGINNING at an iron pin on the northern side of Broadleaf Court, joint front corner Lots Nos. 25 and 26 and running thence with the joint line of said lots, N. 9-0 W. 148.3 feet to an iron pin; thence N. 86-56 E. 80.5 feet to an iron pin, joint rear corner Lots Nos. 26 and 27; thence with the joint line of said lots, S. 9-0 E. 115.1 feet to an iron pin on Broadleaf Court; thence with Broadleaf Court, following the curvature thereof, the chord of which being S. 64-33 W. 34.5 feet to an iron pin; thence continuing to follow the curve of said Court, the chord of which being S. 64-43 W. 49.3 feet to the beginning corner; being the same conveyed to me by J. H. Mauldin by his deed of even date to be recorded herewith.
