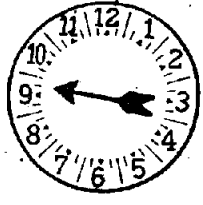

WHEREAS, the Mortgagor is well and truly indebted unto TRYON FEDERAL SAVINGS AND LOAN ASSOCIATION OF TRYON, N. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Four Thousand Six Hundred Twelve and No/100** DOLLARS (\$ **4,612.00**), with interest thereon from date at the rate as specified in said note, said principal and interest to be repaid as therein stated, and
