WHEREAS, the Mortgagor is well and truly indebted unto

organized and existing under the laws of **South Carolina**, hereinafter

sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its

Western side of Knox Street near the City of Greenville in the County
of Greenville, State of South Carolina and known and designated as the
