Court of said state, at chambers or otherwise, as so have ledge of the Courty Court in any county which has a county court, for the appointment of a receiver, with methodity to take possession of said premises and collect said rents and profits, applying the said profits (after paying the cost of collection) upon said debt, interest, cost and expenses without liability to account for anything more than the seast and profits actually collected.
