ARTHUR C. KELLY of Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

All that piece, parcel or lot of land situate, lying and being in Greenville County, South Carolina, known and designated as Lot No. 81, as shown on a plat of the Subdivision of OAK CREST, Section 1, recorded in the R. M. C. Office for Greenville County, in Plat Book GG, Page 131.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
