All that lot of land in Greenville County, State of South Carolina, on the Eastern side of Marion Road, near the City of Greenville, being a portion of Lots 113 and 114 as shown on plat of Parker Heights, recorded in Plat Book P at page 43 and described, according to a survey made by J. C. Hill on October 17, 1959, as follows:
