

All that certain lot, tract or parcel of land known and designated as Lot No. *B* on Estate Plat No. 18 of property of A. B. Groce Estate, located about five (5) miles West of Gramling, South Carolina, in Spartanburg and Greenville Counties, the said plat being made by Gooch & Taylor, Surveyors, July 21, 1942 from survey made by Gooch & Taylor, Surveyors, and from plat made by J. H. Atkins, July 21, 1921, which said Gooch & Taylor plat is recorded in the R. M. C.
