and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot No. 8, Map of Buncombe
Park, which plat is recorded in the RMC Office for Greenville County, South Caro-
lina, in Plat Book M, page 12, and having, according to said plat, the following
metes and bounds, to-wit:

BEGINNING at an iron pin on the north side of South Haven Drive, joint front corner
Lots 8 and 9; said iron pin being 405 feet in an easterly direction from the intersection
of Old Buncombe Road and South Haven Drive; and running thence N. 3-20 W. 173 feet
to an iron pin; thence S. 88-00 W. 75 feet to an iron pin, joint rear corner Lots 7 and 8;
thence S. 3-20 E. 173 feet to an iron pin on South Haven Drive, joint front corner Lots
7 and 8; thence along South Haven Drive N. 88-00 E. 75 feet to an iron pin, point of
beginning.

ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

assigns forever.
