NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township,  
on the South side of Scuffletown (Woodruff Road) Road, and having  
the following metes and bounds:

BEGINNING at a point on the northern side of said road over the culvert over a small branch; thence with branch S. 20-19 W. 423.6 feet to a point in said branch at a bend; thence with said branch S. 10 E. 718 feet to the center line of said branch (iron pin on west bank) thence S. 75-45 W. 235 feet to an iron pin in the pasture; thence N. 14-15 W. 1074 feet to a point in center line of said road; thence along the center line of said road, N. 75-45 E. 525 feet to the beginning. Containing 7.5 acres, more or less.
