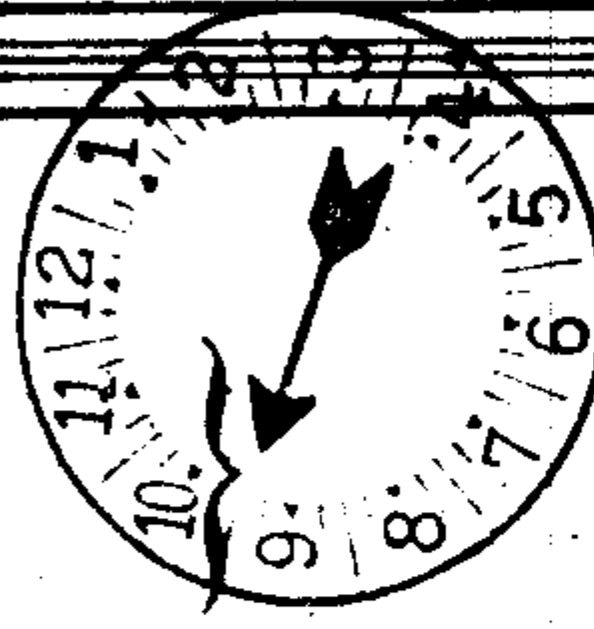

in the full and just sum of **Three Hundred Twenty Eight and 18/100 ( \$ 328.18)**

, to be paid **Payable at the rate of twenty seven and 34/100 \$ 27.34 each month until paid in full.**

, with interest thereon from **Maturity ( One year from date)**

at the rate of **7%** per centum per annum, to be computed and paid **Annually**

until paid in full; all interest not paid when due to bear
