"BEGINNING at an iron pin at the joint front corner of Lots #29 and #30, and running thence along the lines of these lots, S. 9-0 E. 150.1 feet to an iron pin; running thence N. 81-0 E. 80 feet to an iron pin at the joint rear corner of Lots #29 and #28; running thence N. 9-0 W. 129.3 feet to an iron pin on the Southern side of Broadleaf Court at a turnaround; thence along said turnaround, S. 68-10 E. 10.4 feet to an iron pin; thence continuing along said turnaround, S. 81-10 E. 49.3 feet to an iron pin; thence continuing along the southern side of Broadleaf Court, S. 81-0 E. 24.2 feet to an iron pin, point of beginning; being the same conveyed to me by J. H. Mauldin by deed of even date, to be recorded herewith."
