WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of EIGHT THOUSAND EIGHT HUNDRED AND NO/100-----

DOLLARS (\$ 8,800.00-----), with interest thereon from date at the rate of Six (6%) ---- per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All those two lots of land in Greenville County, State of South Carolina, on the Northeast side of the Parker Road, in Greenville Township, shown and designated as lots # 5 and 6, on a plat of property of James M. Clark recorded in Plat Book H at Page 175, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northeast side of Parker Road, at joint front corner of lots # 6 and 7, and running thence with the line of lot # 7, N. 38-16 E. 343.3 feet to pin; thence S. 25-54 E. 159.2 feet to pin; rear corner of lot # 4; thence with the line of lot # 4, S. 38-16 W. 274 feet to pin on Parker Road; thence with the northeast side of Parker Road in a northwestern direction 143 feet to the point of beginning.

Being a portion of property conveyed to J. M. Clark by deed recorded in Deed Book 74 at page 490. Mortgagors being all of the heirs of J. M. Clark except two minor children, Carolyn Clark and Sandra Clark, whose interests are conveyed by E. Inman, Master, to the mortgagors, by deed to be recorded herewith.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
