All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in The City of Greenville, on Calvary Street, having the following metes and bounds, to-wit:

BEGINNING at a stake on Calvary Street, at corner of lot recently conveyed to Robert Brown, and running thence in a northerly direction with said street, 32.83 feet to a stake on said street; thence N. 61-35 W. 88.65 feet to a stake; thence S. 28-15 W. 32.83 feet to a stake on Robert Brown's lot; thence along his line, S. 61-35 E. 88.5 feet to a stake, the point of beginning.
