NOW, KNOW 'ALL MEN, That I, the said L. M. Brown

in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

Wm. R. Timmons, Jr., his heirs and assigns forever:

All that certain piece, parcel or lot of land in Austin Township, Greenville County, State of South Carolina, within the corporate limits of the City of Mauldin, and being known and designated as Lot Number 80 of a subdivision known as Glendale, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book QQ at Pages 76-77, and having the following metes and bounds, to-wit:

BEGINNING at a point on the Southern side of Fairfield Drive at the joint front corner of Lots 79 and 80 and running thence S. 11-16 W. 155 feet to a point at the joint rear corner of Lots 79 and 80; thence N. 78-44 W. 95 feet to a point at the joint rear corner of Lots 80 and 81; thence N. 11-16 E. 155 feet to a point on the Southern side of Fairfield Drive at the joint front corner of Lots 80 and 81; thence with the Southern side of Fairfield Drive, S. 78-44 E. 95 feet to the point of beginning; being the same conveyed to me by Wm.
