MORTGAGE OF REAL ESTATE

COUNTY OF Greenville To All Whom These Presents May Concern: I, W. C. Balentine, of Greenville County SEND GREETINGS:

WHEREAS, I/we the aforesaid mortgagor(s) in and by my/our certain promissory note, in writing, of even date with these presents am/are well and truly indebted to FIRST FEDERAL SAVINGS & LOAN ASSOCIATION OF GREEN-

VILLE, in the full and just sum of Twelve Thousand, Four Hundred and No/100 -(\$ 12, 400, 00) Dollars (or for future advances which may be made hereunder at the option of said Association, which advances shall not exceed the maximum amount stated herein and shall be evidenced by a subsequent promissory note or notes se-

cured hereby), said note to be repaid with interest at the rate specified therein in installments of...

Ninety-Seven and 54/100 - - - - - - (97.54 - - - -) Dollars upon the first day of each and every calendar month hereafter in advance, until the full principal sum, with interest, has been paid, such monthly payments to be applied first to the payment of interest, computed monthly on the unpaid principal balances, and then to the payment of principal. The last payment on said note, if not paid earlier and if not subsequently

NOW KNOW ALL MEN, That I/we, the said mortgagor(s) in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, according to the terms of said note, and also in consideration of the further sum of Three Dollars to me/us the said mortgagor(s) in hand well and truly paid by the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, at and before the signing of these presents (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, the following described property, to-wit:

"All that certain piece, parcel or lot of land, with all improvements thereon, or to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, being known and designated as Lot No. 64 as shown on Plat No. 3, Cherokee Forest, prepared by J. Mac Richardson, R.L.S. in January, 1959, and recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at Pages 36 and 37, and having, according to said plat, the following metes and bounds, towit:

"BEGINNING at an iron pin on the southern side of Roberta Drive, the joint front corner of Lots Nos. 64 and 65, and running thence along the said southem side of Roberta Drive, S. 61-52 E. 56.3 feet to an iron pin; thence continuing with Roberta Drive, S. 74-02 E. 44 feet to an iron pin, the joint front corner with Lot No. 63; thence turning and running S. 15-58 W. 209.2 feet to an iron pin; thence N. 73-45 W. 102 feet to an iron pin; thence N. 16-44 E. 220.6 feet to an iron pin, the point of beginning; being the same conveyed to me by Wilkins Norwood & Company, Inc. by deed dated November 20, 1959, to be recorded herewith."
